If you signed up for CEU's, here is what to do on Symposium Day

IF you marked **Pesticide Applicator Recertification** credits or **Connecticut Recreation and Parks Association** CEUs when you registered, you will need to enter a code when you see the the code appear on the screen. **CODES** will be displayed on your monitor during the Keynote, Roundtable, and each Breakout Session.

At the top of the screen, there will be a Verification Tab.

Click on that and then enter the code you see on your monitor.

The records of your attendance will be sent to DEEP and/or CRPA.

IF you signed up for **other CEU's (OR if you were not seeking CEUs at all), just ignore the code** when it appears on your monitor.

For those who signed up for CEUs that did not require entry of codes, we will provide a record of your log on to groups that requested it.
